

**NOTICE OF PUBLIC MEETINGS

**PROPOSED AMENDMENT TO THE REDEVELOPMENT PLANS FOR THE SAN JACINTO  
REDEVELOPMENT PROJECT AREA AND THE SOBOBA SPRINGS REDEVELOPMENT  
PROJECT AREA**

The Redevelopment Agency of the City of San Jacinto ("Agency") has initiated the process to consider the following actions: 1) merge the San Jacinto Redevelopment Project Area and the Soboba Springs Project Area (collectively, the "Existing Project Areas") for financial reasons; 2) update and expand the capital improvements projects lists for the Existing Project Areas; 3) adopt a single Merged, Amended and Restated Redevelopment Plan (the "Merged Plan") to cover the Existing Project Areas; and 4) re-instate eminent domain authority in the San Jacinto Project Area for a 12 year period. All of the foregoing proposed actions are referred to collectively as the "Amendments" and will be undertaken pursuant to the Community Redevelopment Law (California Health and Safety Code Section 33000, et seq. "Redevelopment Law").

Maps of the Existing Project Areas are available for public review at the City Clerk's Office located at 595 S. San Jacinto Avenue, Building B, San Jacinto, California.

**PROJECT AREA COMMITTEE FORMATION**

The San Jacinto City Council ("City Council") is providing for the formation of a Project Area Committee ("PAC") to facilitate public involvement by residents, property owners, business interests and community organizations in the San Jacinto Project Area in the redevelopment plan amendment process. The PAC will function as an advisory body that reviews the draft Merged Plan and, in particular, will consult on housing and residential matters and provide a forum for information dissemination.

The purpose of the first meeting will be to: (1) discuss the proposed Amendments; (2) explain the formation of, functions of, and opportunity to serve on, the PAC; (3) distribute pertinent written information; and (4) distribute applications to those persons interested in serving on the PAC and voter eligibility forms.

To be a PAC member, you must be eighteen (18) years of age or older and you must reside, own property, operate a business, or be a representative of an existing community organization within the San Jacinto Project Area boundaries. All qualified persons will be eligible for election to the PAC. Applications for PAC membership will be available at the PAC Information Meeting on May 6, 2009, at the City Clerk's Office beginning on May 6, 2009, or at the city's website at

www.ci.san-jacinto.ca.us for persons interested in being elected to the PAC. Completed applications must be received by the Agency by 5:00 p.m. on May 13, 2009.
